50 YEAR PRORATED WARRANTY

1. CANTAR/POLYAIR CORPORATION extends this warranty to the original purchaser of a SummerFun[®] pool. This warranty covers the SummerFun[®] pool only. Other equipment such as filters, ladders, slides, heaters, etc. are not supplied nor manufactured by CANTAR/POLYAIR CORPORATION. Their warranties should be found in their respective cartons.

2. This pool is warranted to be free of manufacturing defects.

This warranty is null and void if the design of this product is altered. The product must be assembled according to the factory directions and no changes made in any of the parts.

The purchaser is urged to carefully observe and follow cautions in the installation manual in order to avoid inadvertent damage.

All commitments by manufacturer shall be declared null and void if the purchaser fails to comply with instructions pertaining to assembly, care and maintenance as outlined in detail in Cantar's installation manual.

3. No incidental, consequential, or other damages will be paid. Failure of the purchaser to allow the dealer and/or manufacturer to inspect the product claimed defective shall render the warranties made hereunder null and void.

4. UNDER NO CONDITIONS WILL CANTAR/POLYAIR CORPORATION BE RESPONSIBLE FOR THE COST OF LABOR AND/OR WATER OR CHEMICAL LOSS OR ANY DAMAGES RESULTING FROM FAULTY INSTALLATION OR FAULTY PRODUCT.

This warranty is voided if the pool is left standing without water exposing the liner to direct sunlight for a period in excess of one day. If for any reason it is necessary to empty water from the pool, it should be refilled the same day.

5. The factory warranty does not cover: Ice damage to the liner, damage to the liner from plant or animal, puncturing or trimming the liner for any reason including incorrect cutting of the liner for "through-wall skimming", damage or destruction to life or property that is directly or indirectly incurred through the use or existence of this product.

6. To obtain performance under this warranty, within ten days of discovery, the purchaser should contact CANTAR/POLYAIR CORPORATION. A sales slip indicating the date of purchase must be submitted with claim.

7. **REPAIRS** Due to chemical conditions in water and/or exposure to sun, empty liners are subject to shrinkage. To avoid this repairs should be made "on site" whenever possible. Before liners or parts are removed, secure permission from your Cantar dealer or direct from CANTAR/POLYAIR CORPORATION's Customer Service Department.

8. **PRO-RATE SCHEDULE** For this purpose "season" means one year from the date of purchase. CANTAR/POLYAIR CORPORATION reserves the right to repair or replace the defective part.

When the fault is CANTAR/POLYAIR CORPORATION's: First season replacements, with the exception of those stipulated in this warranty, will be at no charge to the consumer.

50 YEAR PRORATED WARRANTY After the first anniversary following purchase and for the next forty-nine (49) years a pool found to be defective will be replaced at a prorated cost equal to the, following percentages of the then existing manufacturer's suggested retail price:

2nd year	25%	11 to 15 years	75%
3 to 6 years	50%	16 to 25 years	90%
7 to 10 years	65%	26 to 50 years	95%

Although any warranties implied are limited to the fifty (50) year period after the date sold to the original purchaser, some states and/or provinces do not allow limitations on the length of time of an implied warranty. Therefore, the above may not apply in such states/provinces. Any claimant under this warranty has specific legal rights and the provisions in the warranty are neither a modification nor subtractions, but rather, an addition to the statutory warranties and other rights and remedies contained in the applicable state or provincial legislation.

Manufacturer will not be liable for any incidental or consequential damages resulting from any defects in workmanship or material. Some states and or provinces do not allow the exclusion or limitation of incidental or consequential damages, therefore the foregoing limitation or exclusion may not apply.

This warranty gives the original consumer purchaser specific legal rights. The purchaser also has implied warranty rights. In the event of a problem with warranty service or performance, you may be able to go to a small claims court, a state court or a federal district court.
